

E-Learning Preparation for IPMA Certification - Level D

The course provides participants with the necessary tools for adequate preparation for the Certification exam, level D, according to the international standard **Individual Competence Baseline (ICB4)** codified by IPMA (International Project Management Association). In particular, it integrates the skills that the participants have acquired in project management with the methodologies that are the basis of Project Management and which constitute the contents of the exam tests required for Professional Certification according to the IPMA ICB4 Standard, level D.

The course examines 28 Project Management “Competences” in **three Areas**.

“**PRACTICE**” Area (Methodologies) deals with the fundamental approaches and methodologies for setting up, planning and managing projects.

In the “**PEOPLE**” (Behavior) Area, issues concerning human aspects, behavior and social relationships are addressed.

In the “**PERSPECTIVE**” Area, the skills relating to the context in which the project is carried out are covered.

In addition to displaying professional project management skills in a systematic and integrated manner, the course offers suggestions (*Examination tips*) on how to approach the exam tests: multiple choice questions and open questions, as well as, in the final module, advice on how to carry out the exam itself optimizing times.
